

Data protection information clause

The provision of personal data is voluntary, but is necessary for the execution of the agreement. In case of refusal to provide your personal data, then the Administrator has the right to refuse to conclude the agreement.

Your personal data may be shared with the following categories of entities: law, notary, bailiff, accounting firms, couriers and postal operators, law firms affiliated with the Administrator with whom it has a permanent cooperation agreement, entities providing backup maintenance services and data storage services, to suppliers responsible for handling information systems, courts, public authorities in connection with the implementation of legal obligations incumbent on the Administrator.

Your data may be transferred outside the European Union and the European Economic Area (EEA). The Administrator in relation to transfer of personal data outside the EEA ensured that the entities to which these data are transferred provide a guarantee of a high degree of protection of personal data. These guarantees arise in particular from the commitment to use standardized contractual clauses adopted by the (EU) Commission or participation in the Privacy Shield program established by Commission Implementing Decision (EU) 2016/1250 of 12 July 2016 on the adequacy provided by the EU-U.S. Privacy Shield.

Your data obtained for the purpose of concluding an agreement are kept for the period of agreement negotiation, and by the end of the calendar year following the year in which you last made contact regarding its conclusion, if the conclusion of the agreement did not take place. We process your data obtained in connection with the conclusion of a contract until the end of the limitation period of potential claims from the agreement.
